- You will be required to upload a scan of your proof of purchase detailing a single purchase of XTV vehicle and XTV accessories with the list price clearly shown for each item.
 - Invoice must clearly indicate the purchase date, dealer name, address, model and description of the Mahindra XTV and accessories.
- **The rebate claim must be submitted within 30 days from the purchase invoice date to the claims processing center.**
